I. Guidelines to the direct billing network

When attending the hospital for in-patient, daycare or out-patient treatment, please follow the procedures listed below:

- 1. Please show your Membership Card and proof of identification to the receptionist prior to the consultation.
- 2. Sign the Letter of guarantee for hospital expenses or Claim form to acknowledge receipt of the treatment following the hospitalisation.
- 3. Settle any co-insurance, excess amounts or uninsured items with the hospital prior to leaving.

II. Uninsured items

The following is a list of some of the general benefit exclusions under your UltraCare Plan. This is not a complete list and does not replace the policy wording. In case of any queries, please contact us for clarification.

- Any Co-insurance or excess applicable. (As show on the membership card).
- 2. All out-patient treatments under Standard Plan (except post-hospitalisation) see terms and conditions.

- 3. Dental. Wellness. Vaccinations.
- 4. Pre-existing conditions (any medical conditions which existed before the commencement date). See Benefit Exclusions BE1 in your Plan Guide for a definition of a pre-existing condition.
- 5. Alcohol, drug or any other intoxicating substance abuse or any addictive condition.
- 6. Infertility treatment or fertilization, treatment for sexual problems.
- 7. Sexually transmitted diseases.
- 8. Experimental or unproven treatment.
- 9. Congenital abnormalities or birth defects.
- 10. Suicide, willful, self-inflicted.
- 11. Sleep apnoea, snoring or insomnia.
- 12. Cosmetic, reconstructive or remedial disorder.
- 13. Special diet, weight control, children's food, vitamin, mineral or organic supplements.

III. Important notes

- 1. The direct billing services are not available to obtain any treatment, which falls outside the scope of your policy.
- 2. Membership card is not a credit card or guarantee of payment. Please follow the guidance of the hospital administration team.
- 3. Should you require treatment as an in-patient or daypatient or Emergency Evacuation, please contact First Assistance 24 hours service.
- 4. The Hospital has the right to refuse any Direct Billing arrangement.
- 5. Any Direct Billing that is settled and is subsequently assessed as not being covered under the terms of our policy will be the responsibility of the Policyholder to reimburse the Hospital for the amount due.
